- Register your Jerseys before they are 45 days old and we will automatically report/activate the animal to comply with proAction requirements.

Imported animals will be registered or recorded using the same fees for animals born and first registered/recorded in Canada. However, rather than considering the animal's date of birth, the date the transfer of ownership was processed into Canadian ownership (at the breed registry office of the exporting country) will be used to determine the fee charged for registering/recording the animals in Canada. The privileged lower rate for registration will be available for three months after the breed association of the exporting country has processed the transfer of ownership. After three months, the higher rates will apply.
